## Challenges abound for backcountry recreation

Our federation of 95 clubs has played a critical role in achieving and successfully defending protection for Aotearoa's wild lands and on-nature's-terms recreation for over nine decades.

As a result of past and imminent funding cuts to the Department of Conservation, we are fast approaching a crunch point where we need to stand firm together to ensure that our unique backcountry hut and track network is sufficiently maintained – by one means or another – for the benefit of current and future generations of all who appreciate being able to enjoy our natural wild lands.

We now face powerful economic interests and a political willingness to bypass critical protection mechanisms that have served the backcountry well over many decades.

Times have changed, and we need to be ready to stand firm for what we know are the long-term interest of backcountry recreation.

More than ever before we need your active support, both from continuing to affiliate your members, and also providing on the ground feedback on events in your part of the country. This year we initiated the club korero sessions that provide the FMC Executive with valuable direct feedback from a diverse range of clubs – we appreciate those clubs and supporters that have joined past sessions and encourage you to join future sessions to enable immediate update on issues of concern.

We are listening to the challenges clubs face to distribute the boxes of *Backcountry* magazines that in the past have arrived quarterly – we acknowledge that onward distribution (if it can't be achieved in person at club nights) is costly and administration time intensive. The magazine contains a wealth of information on current issues and events, so we are keen that our members do continue to have timely access to that information.

The easiest method for clubs to achieve distribution of the printed magazine to their members is to sign them up for the existing Direct To You (D2U) service that ensures that the magazine is on its way directly to your members as soon as it is printed. This year, also, we will likely be trialling an online digital mechanism whereby each new edition will be accessible online immediately to club members.

We trust that you are now progressing the work require to create your new club constitution as an important step towards achieving the mandatory incorporated society re-registration required by April 2026. Refer to various articles that have appeared in recent *Backcountry* magazines, and the advice provide on our Wilderlife website at this link

For partially affiliated clubs and national bodies we request that you seriously consider the value that FMC provides to <u>all</u> of your members and renew your membership with increased resolve and declared membership numbers to provide essential support to FMC in these challenging times.
